Nature and description of the legal proceedings		This case involves the enforcement of a foreign judgment rendered against the Issuer in Malaysia for guarantees it issued on various construction projects involving Malaysian Ringgit (MYR) 5,108,290.23. The trial court and the Court of Appeals rendered a decision in favor of the Issuer.  The Supreme Court (SC) rendered a decision reversing the decision of the Court of Appeals. The SC ordered the payment of the foreign award in 2001. The trial court issued a Writ of Execution in 2002, and which was partially satisfied but the Issuer later asked for its temporary suspension by moving to quash the writ because of: (a) change of the party's status making the execution inequitable; and, (b) the claim has already prescribed under Malaysian laws. The RTC finally denied the Issuer's motion to quash last year, including the subsequent Motion for Reconsideration. The Issuer have since filed a Petition for Certiorari which is pending in the Court of Appeals. In the meantime, Asiavest's counsel filed for Ex-Parte

· ·		Motion for Issuance of Alias Writ of Execution last April 2016 to enforce the 2002 Writ. The Issuer have since opposed it, prompting Asiavest to file its Urgent Motion to Resolve.
