The Board of Directors, in the special Board of Directors meeting held on 13 September 2016, in its principal place of business, resolved to move the annual stockholders' meeting to the 17th day of October 2016. The Issuer will be unable to hold its annual stockholders' meeting on 19 September 2016 as previously scheduled and disclosed since it has been advised that the Republic of the Philippines through the PMO, which holds 55.72% of the outstanding capital stock, will not be able to secure the authority to attend the meeting before said date.
