
On June 20, 2017, the Issuer filed a disclosure informing the public that Board of Directors of the Issuer resolved to set the annual meeting of the stockholders on 14 September 2017 and has set 30 June 2017 as its record date for determining stockholders entitled to notice and to vote.

However, the Philippine Stock and Exchange Commission notified the Issuer that the set record date of June 30, 2017 was not in compliant with the Disclosure Rules. For the Issuer to be compliant with the PSE's rules, there was a consensus among the members of the Board of the Issuer to amend the record date from June 30, 2017 to July 5, 2017.


