 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders during business hours from October 05, 2022 to October 24, 2022; 8:00 AM to 3:00 PM and October 25, 2022; 8:00 AM to 12:00 noon from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (PhP500.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees along with their submission of their bids.
- 6. The PNCC will hold a Pre-Bid Conference on as per request at Material Management Division Office, PNCC Compound, K.M 15 East Service Road, Bicutan, Paranaque City and/or through video conferencing or webcasting *via PNCC website*, which shall be open to prospective bidders.
