Bids received in excess of the ABC shall be rejected automatically during the bid opening. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Prospective Bidders may obtain further information from PNCC and inspect the Bidding Documents at the address given below during business hours from 8:00 A.M. to 3:00 P.M. or at the PNCC website (optional).

A complete set of Bidding Documents may be acquired by interested Bidders on January 10, 2023 from the given address and website(s) below, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB), in the amount of Ten Thousand Pesos (PhP 10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees along with the submission of the bids.

PNCC will hold a Pre-Bid Conference on January 18, 2023 at the PNCC's Director's Lounge, PNCC Compound, K.M 15 East Service Road, Bicutan, Parañaque City and/or through video conferencing or webcasting via PNCC website, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at Materials Management Department Office, PNCC Compound, K.M. 15 East Service Road, Bicutan, Parañaque City. Late bids shall not be accepted.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

Bid opening shall be on January 30, 2023 at the PNCC Board Room, PNCC Compound, K.M 15 East Service Road, Bicutan, Parañaque City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

PNCC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
