The **Philippine National Construction Corporation (PNCC)**, now invites bids for the:

Bids received in excess of the ABC shall be automatically rejected during the bid opening. Bidders should have completed, within three (3) years prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Prospective Bidders may obtain further information from PNCC and inspect the Bidding Documents at the address given below during business hours from 8:00 AM - 3:00 PM or at the PNCC website (optional).

A complete set of Bidding Documents may be acquired by interested Bidders during business hours from June 4, 2025 to June 24, 2025; 8:00 AM to 3:00 PM from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (PhP2,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees along with their submission of their bids.

The PNCC will hold a Pre-Bid Conference on June 10, 2025, 2:00 PM at the PNCC Board Room, PNCC Compound, KM. 15 East Service Road, Bicutan, Paranaque City and/or through video conferencing or webcasting via PNCC website, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at Materials Management Department Office, PNCC Compound, KM. 15 East Service Road, Bicutan, Paranaque City on or before June 24, 2025 at 1:30 PM. Late bids shall not be accepted.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bid opening shall be on June 24, 2025; 2:00 PM at the PNCC Board Room, PNCC Compound, KM. 15 East Service Road, Bicutan, Paranaque City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The PNCC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
