This Bid Bulletin No. 1 is being issued to clarify matter in the Pre-Bid conference for the aforesaid project:

While the provision of DOLE Department Order (DO) No. 150-16, dated 16 February 2016, entitled *Revise Guidelines Governing the Employment and Working Conditions of Security Guards and other Private Security Personnel in the Private Security Industry* imposes a minimum administrative fee of 20% of the total contract cost for Service Agreement for security services, the Government Procurement Policy Board (GPPB) is of the position, as stated in their issuances, particularly: GPPB Resolution No. 14-2012 dated 1 June 2012; GPPB Resolution No. 14-2015 and GPPB Circular 02-2013 dated 11 April 2014, as well as the case of Philippine Sports Commission, et. al v Dear John Services, Inc., that the aforesaid minimum administrative fee runs counter to the provision of Sec. 31 of the Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations.

In view of the foregoing, PNCC-BAC shall adhere to the stand of GPPB, as it is in accordance with the provisions of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.

This Bid Bulletin No.1 shall form part of the Bidding Documents. Any provisions in the Bidding Documents or prior oral communication inconsistent herewith is hereby amended, modified, and superseded accordingly.
